

# APPLICATION FOR SPOUSE/JUNIOR MEMBERSHIP

### 1. Junior Member

- i. A Junior Member shall be a person of the Chinese race below the age of 21 years whose parent is a member of the Club.
- ii. A Junior Member has no voting rights and no voice in the management of the Club.
- iii. A Junior Member may not introduce guests.
- iv. A Junior Member attaining the age of 21 shall automatically cease to be a Junior Member. He may apply to become an Ordinary Member after paying the entrance fee and subscription equivalent to that paid by an Ordinary Member. A Junior Member with a continuous membership of 5 years or more may pay an entrance fee at a discount rate commensurate to his years of membership as determined by the General Committee.

He/She may apply, but on the condition of not later than eight (8) years after ceasing being a Junior Member, to become an Ordinary Member or an Ordinary Transferable Member subject to the approval of the General Committee and upon such terms and conditions as shall be imposed by the General Committee including the payment of an entrance fee and subscription fee, the amount of which shall be determined by the General Committee from time to time but shall not be more than the applicable to that paid by an Ordinary Member or an Ordinary Transferable Member, as the case maybe.

### 2. Spouse Member

- i. A Spouse Member is the spouse of an Ordinary Member, Ordinary Transferable Member, Life Member, Life Transferable Member, Honorary Member, Outstation Member or Trustee of Victoria Green.
- ii. The spouse of a Corporate Member will, on the said Member's application and at the discretion of the General Committee, be a Spouse Member of the Club.
- iii. A Spouse Member is not subject to an entrance fee.
- iv. A Spouse Member may not introduce guests to the Club.
- v. A Spouse Member has no voting rights and no voice in the management of the Club.
- vi. The Spouse Member of a deceased Ordinary Member and Life Member may apply to become an Ordinary Member subject to the approval of the General Committee and upon payment of the conversion fee as determined by the General Committee.
- vii. The Spouse Member may apply to become an Ordinary Transferable Member subject to the approval of the General Committee and upon such terms and conditions as shall be imposed by the General Committee including the payment of an entrance fee and subscription fee, the amount of which shall be determined by the General Committee from time to time but shall not be more than the amount applicable to that paid by an Ordinary Transferable Member.
- 3. The application form must be duly completed, with the following relevant documents.
  - i. 1 Passport size photograph
  - ii. Photocopy of Marriage/Birth Certificate
  - iii. Photocopy of Identity Card
- 4. The proposer of such membership must be a husband/wife/parent who is presently a Club member.

### 5. Subscription for Junior Member/Spouse Member

- i. Monthly: RM 5.30/RM 19.10
- ii. Yearly: RM 63.60/RM 171.70
- iii. Concession Rate: RM 47.70/RM 228.95
