## CONVERSION FROM JUNIOR/SPOUSE TO OM/OTM MEMBERSHIP

### 1. Ordinary Member

- i. An Ordinary Member shall be a person of 21 years of age or above residing or working in the State of Pulau Pinang.
- ii. He may, after being a member of the Club for not less than 6 months, propose or second an applicant for membership.
- iii. He may introduce guest to the Club.
- iv. He may, with one or more Ordinary/Life Members or Ordinary/Life Transferable Members give notice of any proposal for consideration at the Annual General Meeting.
- v. He may be allowed to stand for election after being a member for 1 year and shall have the right to vote after confirmation.

### 2. Ordinary Transferable Member

- i. An Ordinary Transferable Member shall be a person of 21 years of age or above residing or working in any State in Malaysia whose membership is transferable.
- ii. He may, after being a member of the Club for not less than 6 months, propose or second an applicant for membership.
- iii. He may introduce guest to the club.
- iv. He may, with one or more Ordinary/Life Members or Ordinary/Life Transferable Members give notice of any proposal for consideration at the Annual General Meeting.
- v. He may be allowed to stand for election after being a member for 1 year and shall have the right to vote after confirmation.
- vi. He may transfer this membership to any person, subject to the approval of the General Committee and on payment of a transfer fee, as determined by the Committee.
- vii. Upon death, the membership may be transferred to the nominee, subject to the approval of General Committee and on payment by the nominee of a transfer fee as determined by the General Committee. If the nominee is below the age of 21, he has no voting right and no voice in the management of the Club.

### 3. The application form must be duly completed, with the following relevant documents.

- i. **1 Passport size photograph**
- ii. **Photocopy of Identity Card**
- iii. **Junior/Spouse Membership card for return**
